- I have not been diagnosed with Coronavirus/COVID-19 and not-yet cleared as non-contagious by state or local public health authorities
- I am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19
- I will abide by all verbal and written instructions given to me by F&S Management LLC dba Amarillo Bulls Hockey and their employees.
